We are pleased to inform all concerned that the Board of Directors of **Bangladesh Steel Re-Rolling Mills Limited (BSRM)** in its 405th Meeting held on December 19, 2018 at 5:00 PM has approved equity investment of Tk. 39.00 crore (approx.) equivalent to USD 4.67 million (representing 18%) in BMS Steel Limited, a new joint venture company, formed in Kenya along with investment partners from Mauritius and United Arab Emirates. The investment partners have operations in Kenya and other countries in Africa. BMS Steel Limited will set up a manufacturing facility with total investment of about USD 65 million to produce 0.4 million metric tons of MS Bars and Sections per year.
